LONGFIELD SOLAR FARM – ACTION TAKEN BY PARISH COUNCIL TO 15TH NOVEMBER 2020

1. The slide presentation from Longfield Solar Farm (Newgate Communications) on 22nd October 2020 to Parish Council by Zoom, uploaded to the Terling & Fairstead Council website: <http://terlingandfairstead.btck.co.uk/LongfieldSolarFarm>
2. The non-statutory consultation information that was sent to residents by Longfield Solar Farms has been uploaded to the Terling website.
3. Emails sent to surrounding Parish Councils, Braintree District Council, Chelmsford City Council and Essex County Council; contact established with elected District Councillors and County Councillor.
4. The Parish Council is a statutory consultee under the direct application to the Secretary of State planning process, via the Planning Inspectorate and received an Environmental Scoping document from Planning Inspectorate dated 6 November 2020 as part of this process. A formal response is required by 4th December 2020; a link to this document has been uploaded to the Terling Hub and the website as above.
5. Parish Council has requested (via the Terling Hub and the Terling website as above) all Parishioners' views on the Environmental Scoping document and any other concerns which should be emailed direct to the Parish Clerk on: clerk@terlingandfairsteadpc.co.uk no later than 27th November 2020. All comments will be treated in the strictest confidence.
6. The Parish Council has formally requested an extension to the 4th December 2020 deadline, but this has been refused.
7. Parish Councillors attended both Longfield webinars on Thursday 11 November 2020 and Saturday 14 November 2020. These were recorded by Newgate Communications and will be available on the Longfield Solar Farm website. The Parish Council will request a copy of the Q&As submitted, for uploading to the Terling Hub and the website as above.
